

Invitation for Bids for the Re-Construction of School Building

The Government of Nepal [GoN] has allocated funds towards the cost of Re-Construction of School Building for Mahendra Adarsha Vidyashram and intends to apply part of the funds to cover eligible payments under the Contract for contract no. 01/2073/74. Bidding is open to all eligible Nepalese Bidders.

2. Mahendra Adarsha Vidyashram invites sealed bids or electronic bids from eligible bidders for the construction of the Re-Construction of School Building Mahendra Adarsha Vidyashram under National Competitive Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years:

NRs. 3,80,00,000.00

Minimum Work experience of similar size and nature: Least 1 projects with NRs. 3,00,00,000.00

3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Mahendra Adarsha Vidyashram (MAV) or may visit PPMO website www.bolpatra.gov.np/egp

4. A complete set of Bidding Documents may be purchased from the office of MAV eligible Bidders on the submission

of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs. 5000.00 till 15th day of first date of publications. If so requested, the Bidding However, the Employer will not be responsible for delay or non-delivery of the documents so sent. Or Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 5. Pre-bid meeting shall be held at Mahendra Adarsha Vidyashram on 11th day from Noticed at 11:00 PM.

6. Sealed or electronic bids must be submitted to the office by hand/courier or through PPMO website www.bolpatra.gov.np/egp on or before 12:00 PM on 16th day of first date of this notice publication. Bids received after this deadline will be rejected.

7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 PM at the office of MAV. Bids must be valid for a period of 120 after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 10,00,000.00** which shall be valid for 30 days beyond the validity period of the bid.

8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
